DR. DALIA LATKAUSKIENE

Dr. Dalia Latkauskiene je diplomirala na dentalni medicini leta 1999 in nato 2002 končala specializacijo iz zobne in čeljustne ortopedije na Univerzi Kaunas. Od takrat je zaposlena v privatni ordinaciji.

V obdobju 2006-2007 je bila tudi predavateljica na Univerzi Kaunas, v programu specializacije zobne in čeljustne ortopedije. Doktorski študij je zaključila v sodelovanju z Univerzo Riga Stradins, Univerzo v Firencah in Univerzo v Michiganu. Tema njenega doktorskega študija je bil učinek Herbstovega aparata na zobe in čeljustnice pri pacientih RII v obdobju rasti in razvoja.

Vodi številna predavanja na področju uporabe (crowned) Herbstovega aparata, ortodonske obravnave odraslih pacientov, multidisciplinarnе obravnave pacientov in kombiniranega ortodonsko kirurškega zdravljenja. Leta 2012 je skupaj z maksilofacialnim in oralnim kirurgom Grybauskasom že predavala v Ljubljani na tradicionalnem prednovoletnem srečanju Slovenskega ortodonskega društva.

MODIFIED CROWN HERBST FOR EFFICIENT CLASS II TREATMENT

The aim of the course is to present modified crown Herbst and to share clinical tips and tricks in order to achieve efficient and stable results treating moderate to severe Class II cases. Indications and contraindications for the crown Herbst will be discussed. Being a rigid device, Herbst helps to counteract the forces delivered by muscles. This is why the appliance can be used to treat most severe Class II cases when patients reject orthognatic surgery as an option. Since the appliance is not fixed on brackets, less anchorage loss is expected comparing to spring correctors and Class I can be reached in 100% of patients during the functional phase of treatment. Rigid construction allows the clinician to activate just one side of the appliance, this is why crown Herbst can be used to treat Class II/Class I cases, when the Class II has to be corrected just on one side. Appliance construction gives the opportunity to correct upper and lower central lines due to one side activations. Since the appliance is not covering the occlusal surfaces of most of lower and upper teeth, passive vertical migration of teeth not included into anchorage is taking place. This way stable Class I antagonistic contacts develop in posterior segments to enhance stability of the achieved result. Appliance provides some additional clinical benefits which are reducing treatment time with braces as the appliance is removed. Breakage of the crowns is about 1% which makes the appliance reliable and saves the chair time of clinician. Crowns can be ordered from your Ormco dealer in one patient sets, this is why the clinician doesn't have to invest a lot of money to buy the whole set. More than 500 patients were treated with the crown Herbst by the presenter of the course. This enables to show and discuss many different Class II cases, share the tips on clinical management of the appliance. Step by step preparation for the Herbst and installation procedures will be discussed as well as the following treatment with braces and retention protocol. Participants will receive manuals on crown Herbst instructions. Participants are welcome to bring the records of Class II cases to discuss treatment tactics.
